# **Covenant Reminders**

One of the responsibilities of the HOA Board of Directors is to ensure harmony in the neighborhood as well as help preserve the property value of the homes in our neighborhood. Please remember the following from the Goose Creek Covenants:

**Improvements** – all exterior improvements must have prior approval from the Architectural Committee. This includes pools, fences, outbuildings, screen porches, additions or modifications to decks, and exterior paint colors. Forms are available on the website or by calling TPAM.

**Exterior Maintenance** – Each owner must maintain the landscaping, including trees, shrubs and grass within the boundaries of their lots, and the exterior of the home in a neat and attractive condition and in good repair. Please remove clutter from your yard, porch and driveway. Keep garage doors closed when not in use.

<u>Alleyways</u> – The alleys are to be utilized for the sole purpose of providing ingress and egress. NO parking shall be allowed in any alley. No resident or guest shall impede the use of the alley. <u>Common Areas</u> – Please do not store personal belongings in any common area.

<u>**Recreational Vehicles**</u> – No boat, trailer, motorcycle, motor home, camper, plane, recreational vehicle, or *commercial* van, or truck may be parked or stored on any street, any common area or lot except within an enclosed garage.

**Dogs** – Leon County has a leash law and requires that owners pick up after their pets. Please comply.

## What's New?

At the direction of our Board, a small increase in dues was necessary to maintain the common elements up to the standards of the City of Tallahassee and County.
